NOTICE OF REQUISITION OF MEETING OF THE NBA KEFFI BRANCH PURSUANT TO SECTION 10 (1) (a), (b) AND 11 (4) OF THE NIGERIAN BAR ASSOCIATION UNIFORM BYE-LAWS FOR BRANCHES WHICH IS CONTAINED AS THE THIRD SCHEDULE OF THE NIGERIAN BAR ASSOCIATION CONSTITUTION 2015 (AS AMENDED IN 2025).

We, the undersigned financial members of the Keffi Branch, having regards to the laws regulating the activities of each and every branch of the NBA and also having regards to the utter disregards to the Congress of the Branch by the Branch Executive Committee headed by Shuaibu Illiyasu Favour Haruna Esq. during the "EMERGENCY CONGRESS MEETING" held on the 20th February, 2026, hereby give notice for a meeting to be convened for the conduct of the following businesses:

MOTION TO SUSPEND THE EXECUTIVE COMMITTEE OF THE NBA KEFFI 2024-2026 BRANCH AND TO NOMINATE CARETAKER COMMITTEE TO OVERSEE THE AFFAIRS OF THE BRANCH IN THE INTERIM

GROUND FOR REQUISITION:

1. The Branch held a convened General Meeting for the month of January on Thursday the 19th day of February, 2026. The notice to that effect is hereto attached and marked as Exhibit 'A'.
2. The Branch Executive out of utter disregard to the General Meeting sent another invitation on the same Thursday 19th February, 2026 for an "EMERGENCY CONGRESS MEETING" to be held on Friday the 20th February, 2026 at 12:00 noon to conduct a business as important as Nomination of Electoral Committee. A notice to that effect is attached and marked as Exhibit 'B'.
3. The Branch Executive Committee despite calling the meeting to order far beyond the scheduled time, refused to entertain a point of order raised on the legality of the meeting which is an "Emergency Meeting" to conduct such a sensitive matter of the Branch.

4. The Branch Chairman who was presiding over the meeting ruled out the point of order raised by H. M Ramalan esq, the immediate past secretary of the branch and proceeded to read names supposedly for persons to serve as members of the Branch ELCOM.
5. Despite all calls and resistance by the General Meeting on the procedure adopted, the Branch Chairman and his team proceeded with the act.
6. That the Branch Chairman has refused to constitute the Branch Executive Committee in accordance with section 8 (1) of the Uniform bye-laws but has co-opted only the immediate Past Chairman of the Branch Mr. Nuhu John Egya as well as the chairperson of the young lawyers forum in total disregard to the provision of section 8 (1) of the Uniform bye laws.
7. That the Branch Chairman has by virtue of the above, allowed Nuhu John Egya to harass, insult and demean members of the branch while making contributions during congress meetings, this is evidenced by a recorded exchange during the Meeting of the 19th and the 'EMERGENCY' meeting of the 20th of February, 2026.
8. That the Secretary of the Branch has continued to be in disobedience to the provisions of the NBA Constitution, particularly Section 14 (2) (b) (i-ii) and has handed over the attendance register to another Executive Committee member who is not the Assistant Secretary of the Branch under whose custody the attendance register has been tampered with and same has been openly admitted by both the current custodian of the attendance register Mr Ibrahim Usman Aliyu (the financial secretary) and Mrs Rita Maiki (the Vice Chairman) on the Branch WhatsApp platform. The printed relevant portion of the said admission on the Keffi NBA what's App group is attached and marked as Exhibit 'C' and 'D' respectively.
9. That the Secretary has since inauguration never prepared a minute of meeting for circulation to members until the purported "Emergency Meeting" of 20th February, 2026 and same did not capture or reflect the business that was transacted during the said meeting.
10. That the said ELCOM who were purported to be nominated during the "Emergency Meeting" were neither ratified by the congress nor were they sworn in after the purported nomination.
11. That the branch secretary has deliberately omitted the point of order raised by members and included in the minutes of the meeting that Mrs. Chioma Esq., Joyce Anzewu, Esq. and A. C. Ambala, Esq. protested and that purportedly forms the basis for the Chairman, constituting the ELCOM which never happened on the floor of the congress on the 20th February, 2026.
12. That the Secretary manipulated the minutes of meeting of the 20th day of February, 2026 by including in the minutes what did not transpire at the meeting.
13. That there was no time the purported ELCOM was sworn in due to the rejection by Congress, and deeming the swearing in of the purported ELCOM is not just an impossibility



but an aberration and lowers the esteem of the comity of lawyers, as oath taking is embedded in law, guided by the Oath Act and the provisions of the uniform bye laws.

14. That the above facts have clearly provided a situation where the Branch Executive Committee cannot function and conduct an election within the time frame provided by law as the stalemate of the Annual General meeting of 19th of February, 2026 cannot be resolved with the unstatutory emergency meeting of 20th of February, 2026 and there is no foreseeable arrangement of any Annual General meeting by the Executive Committee of the Branch.
















- a. The suspension of the Branch Executive Committee and the appointment of a caretaker committee to oversee the affairs of the Branch pending the publication of a written apology by the Branch Chairman and his team, to the Branch General Meeting on two separate newspapers of wide circulation within the branch.
- b. In the event of a refusal to apologize to the Branch General Meeting which will lift the suspension on the Executive Committee, the Caretaker Committee be mandated to organise and conduct an election into the branch offices within 3 months of their appointment.
- c. The Caretaker Committee shall undertake a comprehensive **AUDIT** of all financial transactions carried out by the branch and report any infraction found therein to the Legal Practitioners Disciplinary Committee for necessary action.
- d. The Caretaker Committee shall undertake a comprehensive **AUDIT** of the branch books including minutes books and attendance register for the sake of sanitizing the books to be clear, comprehensive and accurate.
- e. That upon complying with prayer (a) above and resumption to office, the Branch Executive Committee be **IMMEDIATELY** constituted in accordance with the provisions of section 8 (1) (c) of the Uniform bye-laws.
- f. That upon complying with prayer (a) above and resumption to office, the officers of the branch particularly the Secretary be directed to **IMMEDIATELY** compile and transmit the branch attendance register and continue same as required by the law until vacating the office.






